Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, 'solitaire' design, diamond set ring.

Plain, narrow, tapered band of 2.75mm in width (at base) x 1.01mm depth, with a curved underrail.

Feature 'solitaire' style ring design, consisting of a white gold six claw setting, housing one round brilliant cut diamond, claw set. Secured between the 'cross-over' style extended shoulders of the yellow gold plain and polished band.

Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Finger size is M 1/2.

The ring contains:

- One claw set round brilliant cut diamond, clarity 'Si1', colour 'G'.
Dimensions = 5.22mm(Dia) x 3.18mm(D-estimated) x 3%(Girdle Thickness)
Total Weight = 0.55ct (estimated - see NOTE below)

Total Item Weight = 3.18 grams
Total Gemstone Weight = 0.55ct
Total Metal Weight = 3.07 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
