Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of hand-assembled raised, 14ct white gold & gemset, clip-back pierced earrings.

Feature, "cluster style" pierced/clip on earrings. Comprising, a raised elongated hexagonal-shaped, cluster each contain twenty eight, round brilliant cut diamonds, bead set. Both with plain post & hinged clip back.

Polished finish, stamped "14K K1 JCI" - acid tested as 14 carat gold.

Earring dimensions = 16.21mm (L) x 12.15mm (W) x 4.12mm (D).

The earrings contain:

Twenty bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.63mm (average diameter) x 0.99mm (D-estimated) (smallest)

Dimensions = 2.02mm (average diameter) x 1.23mm (D-estimated) (largest)

Total Weight = 0.40ct (estimated - see NOTE below).

Thirty Six bead set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.35mm (average diameter) x 0.82mm (D-estimated)

Total Weight = 0.35ct (estimated - see NOTE below).

Total Item Weight = 7.06 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 6.91 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond would require removal from the setting. The below replacement figure is based upon crafting a similar pair of earrings, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
