Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 3.09mm width (at base) x 1.88mm depth, with a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The top plate is secured between the 'cross over' style shoulders, that extend out from the plain and polished band. Each of the shoulders houses eighteen round brilliant cut diamonds, claw set.

Polished finish.

Stamped '18K GS' - acid tested as 18 carat gold.

Ring size: J.

The ring contains:

- One claw set round brilliant cut diamond, clarity is "VV_s2", colour is "J".
Dimensions = 4.92mm(L) x 4.91mm(W) x 2.96mm(D-estimated) x 3.5%(Girdle Thickness)
Total Weight = 0.43ct (known weight - see NOTE below)
- Fifty Two claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).
Dimensions (average) = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 7.95 grams Total Gemstone Weight = 0.85ct Total Metal Weight = 7.78 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 2226972687 Dated: Jun. 21, 2016. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2226972687. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
