Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, multistone ring, of cast construction.

Plain, wide, low half round, tapered band of 6.01mm width (at base) x 1.95mm depth.

Feature octagonal top plate, with a central bezel setting, housing one round brilliant cut diamond, bezel set. Surrounding is one row of twenty round brilliant cut diamonds, claw set. The top plate is secured in between the tapering shoulders of the plain and polished band. The shoulders are embellished with a fluted pattern.

Polished finish.

Stamped 'Au585 RAMZI&CO' - acid tested as 14 carat gold.

Ring size: R.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "P1", colour is "I".

Dimensions = 6.45mm(L) x 6.41mm(W) x 4.01mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.00ct (estimated - see NOTE below)

Twenty claw set round brilliant cut diamonds, clarity is "Si", colour is "light brown tint".

Dimensions (average) = 1.52mm(Dia) x 0.93mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 12.53 grams Total Gemstone Weight = 1.30ct Total Metal Weight = 12.27 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
