Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 18ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.82mm width (at base) x 0.81mm depth, with curved underrail.

Feature, :solitaire style" ring design, with shoulder stones. Comprising, a raised, rub-over setting to top, rhodium plated (worn off) to highlight, houses one round brilliant cut diamond, rub-over set. The extended shoulders, of the yellow gold band, tapers up with a channel setting, end terminations, each contains three tapered baguette cut diamonds, channel set, both sides.



Polished finish, stamped "18K" - acid tested as 18 carat gold. Finger size = M1/2.

The ring contains;

One rub over set round brilliant cut diamond, clarity is "P1", colour is "light brown tint", medium cut quality.

Dimensions = 4.14mm (average diameter) x 2.53mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Six channel set tapered baguette diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Average dimensions = 1.66mm (L) x 0.93mm (W) x 0.68mm (D-estimated) (smallest)

Average dimensions = 1.98mm (L) x 1.24mm (W) x 0.91mm (D-estimated) (largest)

Total Weight = 0.05ct (estimated - see NOTE below).

Total Item Weight = 3.38 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 3.32 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will no be indicative of the resale value of the item.
