Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and 14ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.22mm width (at base) x 1.42mm depth, with a curved underrail.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '14 K michael hill 0.70 TDW 81108' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "light brown tint".

Dimensions = 5.66mm(L) x 5.64mm(W) x 3.44mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.70ct (estimated - see NOTE below)

Total Item Weight = 3.17 grams

Total Gemstone Weight = 0.70ct

Total Metal Weight = 3.03 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
