### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.42mm width (at base) x 1.20mm depth, with a hollow top and shoulders, and open back settings.

Feature 'wave' style band, with a central cultured pearl, glue set. One of the shoulder is embellished with fourteen round brilliant cut diamonds, pave set. The shoulders extend out from the plain and polished band.

Polished finish.

Stamped '750 18K' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One end-drilled semi-round cultured pearl, colour is "white".

Dimensions = 10.17mm(L) x 9.40mm(W) x 9.55mm (D)

Fourteen pave set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.34mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 5.73 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
