## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled raised, 18ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.97mm width (at base) x 1.05mm depth, with cut-out underrail.

Feature, "dress style" design. Comprising, a raised, two claw setting, houses one marquise cut diamond, claw set, to centre. To top side are three baguette cut diamonds, claw set. The extended shoulders, of the band tapers up split to each side of the central setting, one shoulder having a single row graduating down one side, contains nine baguette cut & tapered baguette cut diamonds, channel set.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = L1/2.

#### The ring contains;

One claw set marquise cut diamond, clarity is "Vs", colour is "I", medium cut quality.

Dimensions = 6.14mm (L) x 3.74mm (W) x 2.28mm (D-estimated)

Total Weight = 0.30ct (estimated - see NOTE below).

Twelve claw set tapered & baguette cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 1.74mm (L) x 1.11mm (W) x 0.81mm (D-estimated) (smallest)

Average dimensions = 3.75mm (L) x 1.80mm (W) x 1.31mm (D-estimated) (largest)

Total Weight = 0.60ct (estimated - see NOTE below).

Total Item Weight = 4.40 grams, Total Gemstone Weight = 0.90ct, Total Metal Weight = 4.22 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
