Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-assembled raised, 14ct rose gold &14ct white gold, diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures 2.59mm width (at base) x 1.59mm depth, with curved underrail, open back shoulder settings, underneath.

Feature, "solitaire style" with shoulder stones. Comprising, a raised railed foyr claw white gold setting to top, houses one round brilliant cut diamond, claw set. The extended shoulders, of the rose gold band, tapers up to pointed end terminations, each shoulder contains nine round brilliant cut diamonds, tapering sizes, channel set, to both sides.



Polished finish, stamped "14K, 0.78, michael hill" - acid tested as 14 carat gold.

Finger size = N.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "I", medium cut quality.

Dimensions = 5.06mm (average diameter) x 3.09mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).

Eighteen channel set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.37mm (average diameter) x 0.84mm (D-estimated) (smallest)

Dimensions = 1.55mm (average diameter) x 0.95mm (D-estimated) (largest)

Total Weight = 0.28ct (estimated - see NOTE below).

Total Item Weight = 3.71 grams, Total Gemstone Weight = 0.78ct, Total Metal Weight = 3.56 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
