Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.98mm width (at base) x 1.03mm depth.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and pointed shoulders, of the plain and polished band. Rhodium plating to the setting area.

Polished finish.

Stamped '18K' - acid tested a 18 carat gold.

Ring size: Q.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P3", colour is "H".

Dimensions = 6.49mm(L) x 6.46mm(W) x 3.94mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.01ct (estimated - see NOTE below)

Total Item Weight = 3.05 grams

Total Gemstone Weight = 1.01ct

Total Metal Weight = 2.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
