Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, pendant, of hand-assembled construction.

Feature central cultured pearl, glue set. To the top of the pearl, is a wide fixed bail, housing three vertical rows of four round brilliant cut diamonds, and one horizontal row of four round brilliant cut diamonds, all claw set.

Pendant dimensions = 23.50mm (ave. length) x 14.10mm (ave. width) x 14.56mm (ave. depth).

Polished finish.

Stamped '18K 750 CH' - acid tested as 18 carat gold.

The pendant contains:

One end-drilled semi-round cultured pearl, colour is "black".

Dimensions = 14.67mm(L) x 14.58mm(W) x 14.45mm(D)

Sixteen claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 7.61 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
