Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'dress' style ring, of hand-assembled construction.

Plain, narrow, high half round band of 2.58mm width (at base) x 1.66mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one emerald cut natural aquamarine, claw set. The shoulders are embellished with one three claw setting, housing one round brilliant cut diamond, and a 'twist' style shoulder plate, housing one row of four single cut diamonds, graduating in size. All of the diamonds are claw set. The settings are secured between the shoulders of the plain and polished band.

Polished finish. Stamped '18ct' - acid tested as 18 carat gold. Ring size: K 1/2.

The ring contains:

One claw set emerald cut natural aquamarine, colour is "blue".

Dimensions = 11.25mm(L) x 9.73mm(W) x 6.49mm(D-estimated)

Total Weight = 4.83ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)

Eight claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.30mm (diameter) (smallest)

Dimensions = 1.60mm (diameter) (largest)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 6.40 grams Total Gemstone Weight = 5.03ct Total Metal Weight = 5.39 grams (estimated)

NOTE: The central aquamarine has significant abrasion to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
