## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 3.60mm width (at base) x 0.86mm depth, with open back settings, and a curved underrail.

Feature white gold top plate, with a central four claw setting, housing one natural oval sapphire, claw set. Surrounding is one row of ten round brilliant cut diamonds, varying slightly in size and claw set. The top plate is supported with an open wire base, and is secured between upswept square shoulders, of the plain and polished yellow gold band.



Polished finish.

Stamped '18ct' - acid tested a s18 carat gold.

Ring size: O.

The ring contains:

One claw set oval shaped natural sapphire, colour is "blue'.

Dimensions = 9.95mm(L) x 6.78mm(W) x 3.90mm(D-estimated)

Total Weight = 2.21ct (estimated - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed)

Dimensions (average) = 2.45mm(Dia) x 1.49mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.56ct (estimated - see NOTE below)

Total Item Weight = 7.48 grams Total Gemstone Weight = 2.77ct Total Metal Weight = 6.93 grams (estimated)

NOTE: The central sapphire has significant abrasion to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
