Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.52mm width (at base) x 0.64mm depth, with a curved underrail.

Feature three central raised four claw settings, each housing one round brilliant cut diamond, graduating in size, claw set. The setting is secured to the underrail, and in between the extended and square, upswept shoulders, of the plain and polished band.



Polished finish.

Stamped '18CT A &C' - acid tested as 18 carat gold."

Ring size: O.

The ring contains:

Three claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 3.51mm(Dia) x 2.14mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.65mm(Dia) x 2.23mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.05 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.95 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
