## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'solitaire' style dress ring, of hand-assembled construction.

Feature, narrow, flat, tapered band of 3.43mm width (at base) x 0.68mm depth, with an open back settings.

Feature square white gold top plate, housing one pear shaped diamond, to the centre, gypsy set. The top plate is secured to the tapering shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped 'illegible stamps PALL' - acid tested as 18 carat gold.

Ring size: Z+2.

The ring contains:

One gypsy set pear shaped diamond, clarity is "P1", colour is "H".

Dimensions = 5.74mm(L) x 2.86mm(W) x 1.91mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 6.62 grams

Total Gemstone Weight = 0.18ct

Total Metal Weight = 6.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
