## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand crafted raised, 18ct yellow and white gold, diamond set, multistone ring.

Plain, wide, half round, tapered band, measures 3.60mm width (at base) x 1.64mm depth, with curved underrail, open back setting, underneath.

Feature, "single channel row" style design. Comprising, a white gold channel setting to top, houses five Princess cut diamonds, channel set. The extended shoulders, of the yellow gold band, tapers up wide to the top, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = X1/2.

The ring contains;

Five channel set Princess cut diamonds, clarity is "Vs", colour is "G", medium cut quality.  
Average dimensions = 2.92mm (L) x 2.90mm (W) x 1.91mm (D-estimated)  
Total Weight = 0.65ct (estimated - see NOTE below).

Total Item Weight = 7.80 grams, Total Gemstone Weight = 0.65ct, Total Metal Weight = 7.67 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar material and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
