## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand finished raised, 10ct white gold & gemset, cluster ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.25mm width (at base) x 1.06mm depth, with open back, settings underneath.

Feature, "rectangular-shaped cluster", with shoulder stones. Comprising, a raised cluster grouped together, housing twelve round, faceted diamonds, claw set. Drops to a surround containing twenty six single cut diamonds, claw set. The extended shoulders, of the band tapers up wide, each shoulder containing six black diamonds & eight single cut diamonds, claw set, both sides.



Polished finish, stamped "10K, WGD, 0.68" - acid tested approximately 10 carat gold. Finger size = N.

The ring contains;

Twenty Four claw set round brilliant cut diamonds, colour is "black", medium cut quality.

Dimensions = 1.66mm (average diameter) x 1.01mm (D-estimated) (smallest)

Dimensions = 2.09mm (average diameter) x 1.27mm (D-estimated) (largest)

Total Weight = 0.48ct (estimated - see NOTE below).

Forty Two claw set single cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.05mm (average diameter)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 4.90 grams, Total Gemstone Weight = 0.68ct, Total Metal Weight = 4.76 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond would require removal from the setting. The black gemstones may possibly be treated black diamond or treated synthetic blac moissanite. Limited testing, whilst set, cannot determine the nature of these gemstones. Therefore, the black gemstones require remova from their settings for full and accurate gemmological testing.
