Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of cast consutrction.

Plain, narrow, low half round band of 1.67mm width (at base) x 1.21mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature cushion shaped top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is two rows of round brilliant cut diamonds, claw set. The top plate is secured between 'split' style shoulders, of the plain and polished band. Each of the shoulders is embellished with round brilliant cut diamonds, claw set. There are a total of fiftyfour round brilliant cut diamonds, claw set.



Polished finish.

Stamped 'MHJ' - acid tested as 14 carat gold.

Ring size: K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "I".

Dimensions = 4.38mm(L) x 4.36mm(W) x 2.66mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Fifty Four claw set round brilliant cut diamonds, clarity is "Si & P1 & P2 & P3" (mixed), colour is "H to J" (mixed).

Dimensions = 1.28mm(Dia) x 0.78mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.84mm(Dia) x 1.12mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.70ct (estimated - see NOTE below)

Total Item Weight = 3.21 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.01 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
