Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.56mm width (at base) x 1.28mm depth, with open back settings, and a curved underrail.

Feature three central bezel settings, each housing one round brilliant cut diamond, graduating in size, largest to the centre, and bezel set. The extended and square shoulders, are embellished with one baguette cut diamond, bezel set. The settings are secured to the top of the plain and polished band.

Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: P.

The ring contains:

Three bezel set round brilliant cut diamonds, clarity is "SI2", colour is "G-H", medium cut quality.

Dimensions = 4.20mm(Dia) x 2.56mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.80mm(Dia) x 2.32mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.70ct (estimated - see NOTE below)

Two bezel set baguette cut diamonds, clarity is "Vs", colour is "G".

Dimensions (average) = 3.15mm(L) x 2.40mm(W) x 1.75mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 5.21 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.01 grams (estimated)
