Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, dress style, gem set ring, of cast construction.

Plain, narrow band of 1.69mm in width (at base) x 0.91mm depth, with open back settings.

Feature central four claw setting, housing one oval cut and faceted natural ruby, claw set. To either side, in a triangular formation is three round brilliant cut diamonds, slightly tapering in size, claw set. All secured between the shoulders of the plain and polished band.

Polished finish - stamped '18K' - acid tested as 18 carat gold. Finger size is L.



The ring contains:

One claw set mixed cut oval shape natural ruby, colour 'medium dark red'.

Dimensions = 9.00mm(L) x 7.61mm(W) x 4.15mm(D-estimated)

Total Weight = 2.35ct (estimated - see NOTE below)

Six claw set round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'H to I & light brown tint' (mixed).

Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 2.83 grams - Total Gemstone Weight = 2.57ct - Total Metal Weight = 2.32 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
