Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 14ct white gold, cluster style, gem set, dress ring.

Plain, narrow band of 1.95mm in width (at base) x 1.39mm depth, with a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounded by twenty round brilliant cut diamonds (smallest), claw set. A four claw support base to the setting, all secured between the extended and upswept shoulders of the plain and polished band. Each shoulder having ten round brilliant cut diamonds, claw set.

Polished finish - stamped '8' (partial) - acid tested as 14 carat gold. Finger size is K.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si1', colour 'I'.

Dimensions = 6.40mm(Dia) x 3.90mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.00ct (estimated - see NOTE below)

Forty claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'H to I' (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.44 grams - Total Gemstone Weight = 1.50ct - Total Metal Weight = 4.14 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
