Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold and rhodium plated, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.66mm width (at base) x 1.05mm depth with a hollow top and shoulders, open back settings, and a 'cross over' style underrail.

Feature central square top plate, housing four Princess cut diamonds, invisibly set. The setting is secured between the extended and square shoulders, of the plain and polished yellow gold band. Each of the shoulders is embellished with a white gold panel, housing one row of five Princess cut diamonds, channel set. Rhodium plating to the diamond setting areas.



Polished finish.

Stamped '750 JP88' - acid tested as 18 carat gold.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "J to K" (mixed). Dimensions (average) = 2.70mm(L) x 2.70mm(W) x 1.92mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.50ct (estimated - see NOTE below)

Ten channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to K" (mixed). Dimensions (average) = 2.00mm(L) x 2.00mm(W) x 1.56mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 5.84 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.65 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
