Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.85mm width (at base) x 1.47mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature one central row of seven larger round brilliant cut diamonds, and two outer rows of eleven round brilliant cut diamonds, spanning across the top of the band. All of the diamonds graduate in size, largest to the centre, and are channel set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '10K 3.00 michael hill' - acid tested as approximately 10 carat gold.

Ring size: O.

The ring contains:

Twenty Nine channel set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "G to I" (mixed).

Dimensions = 2.59mm(Dia) x 1.58mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.88mm(Dia) x 2.37mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 3.00ct (estimated - see NOTE below)

Total Item Weight = 8.67 grams Total Gemstone Weight = 3.00ct Total Metal Weight = 8.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
