## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold, gem set, multistone 'dress' style ring, of cast construction.

Plain, wide, low half round, tapered band of 5.83mm width (at base) x 1.49mm depth, with open back settings.

Feature rectangle top plate, with one round brilliant cut diamond, gypsy set, to one end of the top plate. The other end of the top plate, houses one vertical row of two single cut and one round brilliant cut diamonds, claw set. The top plate is secured in between the tapering shoulders, of the plain and polished band.



Polished finish.

Stamped '375 TJPD' - acid tested as 9 carat gold.

Ring size: V.

The ring contains:

One gypsy set round brilliant cut diamond, clarity is "Vs", colour is "G".

Dimensions = 4.00mm(Dia) x 2.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Three claw set single cut and round brilliant cut diamonds, clarity is "Vs & Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.10mm (diameter) (smallest)

Dimensions = 1.20mm (diameter) (largest)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 10.43 grams Total Gemstone Weight = 0.25ct Total Metal Weight = 10.38 grams (estimated)
