## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct yellow gold and 14ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.47mm width (at base) x 1.19mm depth, with a curved underrail.

Feature central white gold four claw setting, housing one glass fracture filled round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '585' - acid tested as 14 carat gold.

Ring size: O.

The ring contains:

One claw set glass fracture filled round brilliant cut diamond.

Dimensions = 6.60mm(L) x 6.55mm(W) x 4.00mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 1.07ct (estimated - see NOTE below)

Total Item Weight = 3.18 grams

Total Gemstone Weight = 1.07ct

Total Metal Weight = 2.97 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, the weight of the diamond is very much an estimation. The diamond has been enhanced by means of filling with a glass type substance. This treatment is not stable and can be damaged by heat or ultrasonic frequencies. Due to this filling, colour and clarity gradings have not been assigned. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques with a fractured filled diamond of similar appearance being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
