Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring. Plain, narrow, reverse tapered band of 2.55mm in width (at base) x 1.02mm depth, with a curved and split underrail.

Feature central four claw setting, housing one oval cut and faceted natural sapphire, claw set. Surrounded by decorative settings, housing twelve round brilliant cut diamonds (largest), claw set, and eight single cut diamonds, bead set.

Polished finish - stamped 'illegible' - acid tested as 9 carat gold. Finger size is M.



The ring contains:

One claw set mixed cut oval-shape natural sapphire, colour 'dark blue'.
Dimensions = 6.25mm(L) x 4.99mm(W) x 3.00mm(D-estimated)
Total Weight = 0.76ct (estimated - see NOTE below)

Twenty claw set & bead set (mixed) round brilliant cut & single cut (mixed) diamonds, clarity 'Vs, Si & P1' (mixed), colour 'H to J' (mixed).
Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 3.53 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 3.33 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
