## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 18ct yellow gold, pearl and diamond set pendant.

Feature pearl cap securing one round-shape cultured pearl, half drilled and glue set. To the centre top is a three claw setting, housing one round brilliant cut diamond, claw set.

All secured in the decorative frame, articulated from the tapering bail assembly.

Polished finish - stamped '18K' - acid tested as 18 carat gold.

Pendant dimensions = 31.00mm (length including bail) x 13.97mm (ave. width) x 11.33mm (ave. depth).

The pendant contains:

One half-drilled round-shape cultured pearl, skin almost blemish free, good lustre.  
Dimensions = 10.50mm (ave. diameter)

One claw set round brilliant cut diamond, clarity 'Vs', colour 'G'.  
Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 4.88 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
