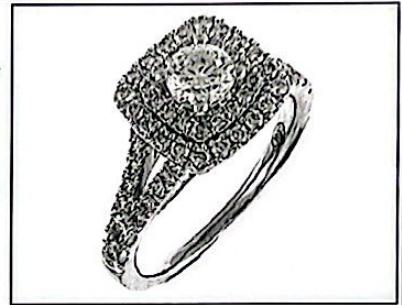

Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring. Plain, narrow, tapered band of 1.64mm in width (at base) x 1.18mm depth, with a curved and split underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounded by two rows, inner row with sixteen round brilliant cut diamonds (smallest) and outer row with twenty round brilliant cut diamonds, all claw set. A fine wire 'scroll' design under the setting, all secured between the split shoulders of the plain and polished band. Each shoulder having five round brilliant cut diamonds to each row, finishing with two round brilliant cut diamonds, tapered to largest, also claw set.



Polished finish - stamped '750 JP02' - acid tested as 18 carat gold. Finger size is M.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P2', colour 'J'.

Dimensions = 5.19mm(Dia) x 3.17mm(D-estimated) x 5%(Girdle Thickness)
Total Weight = 0.53ct (estimated - see NOTE below)

Sixty claw set round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'G to I' (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.77ct (estimated - see NOTE below)

Total Item Weight = 4.89 grams - Total Gemstone Weight = 1.30ct - Total Metal Weight = 4.63 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
