Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 6.51mm in width (at base) x 1.29mm depth, with open back, pierced 'honeycomb' style underrail.

Feature seven row ring design, consisting of a total of ninety-one round brilliant cut diamonds, tapering in size, claw set. Secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'illegible' - acid tested as 14 carat gold.

Finger size is M 1/2.

The ring contains:

Ninety One claw set round brilliant cut diamonds, clarity 'Si', colour 'H to I' (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.00mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.50ct (estimated - see NOTE below)

Total Item Weight = 8.18 grams

Total Gemstone Weight = 1.50ct

Total Metal Weight = 7.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
