## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.26mm in width (at base) x 0.87mm depth, with open back settings.

Feature bezel setting, housing one round brilliant cut diamond, rub-over set. Secured between the 'cross-over' style shoulders, one side bead set with five round brilliant cut diamonds, tapering in size.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is L 1/2.

The ring contains:

One rub over set round brilliant cut diamond, clarity 'P1', colour 'H'.  
Dimensions = 4.39mm(L) x 4.36mm(W) x 2.80mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.34ct (estimated - see NOTE below)

Five bead set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).  
Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 2.35mm(Dia) x 1.43mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 5.00 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 4.90 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
