Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set pendant, of cast construction.

Feature hollow stylised 'tear-drop' pendant design, with pierced decorative backing. The front having a total of one hundred and twenty round brilliant cut diamonds, tapering in size, pave' set.

The bail assembly is formed by the top section.

Polished finish - stamped '18K 750 & unknown symbol' - acid tested as 18 carat gold.

Pendant dimensions = 31.00mm (including bail assembly) x 17.30mm (max. width) x 3.95mm (ave. depth).

The pendant contains:

One Hundred And Twenty pave' set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'G'.

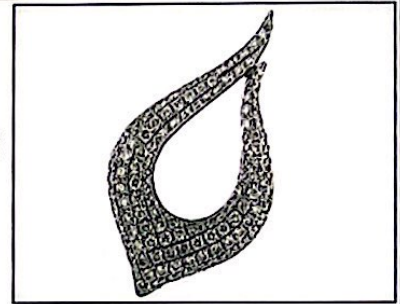
Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 4.78 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
