Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 10ct white gold, dress style, gem set ring.

Plain, wide, tapered band of 10.46mm at top to 3.40mm in width (at base) x 0.97mm depth, with a curved and pierced 'lattice' style underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Each shoulder having a single row of four round brilliant cut diamonds, bead set. The shoulders also having a raised section with 'satin' finish.

Polished finish - stamped '10kt F.D.' - acid tested as approximately 10 carat gold. Finger is V 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P2', colour 'T'.

Dimensions = 3.66mm(Dia) x 2.23mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to H' (mixed).

Dimensions (average) = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 7.40 grams - Total Gemstone Weight = 0.26ct - Total Metal Weight = 7.35 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
