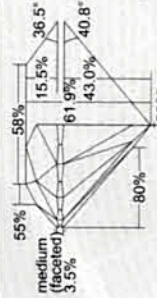

Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, flexible link necklet, of hand-assembled construction.

Feature central 'feline face' reversible style pendant, with a six claw setting, housing one round brilliant cut diamond, claw set, to the reverse. The eyes of the 'feline' have been embellished with two round brilliant cut diamonds, claw set. There is a four claw setting, housing one round brilliant cut diamond, claw set, and a Gucci logo, near the clasp. The pendant is suspended from a filed rectangle link style chain, on both sides. The necklet is finished with a parrot clasp.

Chain dimensions = 37.00cm + 5.00cm (ave. length with extension) x 1.00mm (ave. width).

Pendant dimensions = 6.27mm (ave. length) x 5.88mm (ave. width) x 4.79mm (ave. depth)

Polished finish.

Stamped 'GUCCI made in Italy * 419 AL 750 5182522321 ct. 0.41' - acid tested as 18 carat gold.

The necklet contains:

One claw set round brilliant cut diamond, clarity is "IF", colour is "F".

Dimensions = 4.78mm(L) x 4.76mm(W) x 2.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.41ct (known weight - see NOTE below)

Three claw set round brilliant cut diamonds, clarity is "Vs", colour is "F/G".

Dimensions = 0.91mm(Dia) x 0.56mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.98mm(Dia) x 1.82mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 2.81 grams Total Gemstone Weight = 0.53ct Total Metal Weight = 2.70 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 5182522321 Dated: June 15, 2017. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 5182522321. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
