Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, 2pce ring set, raised 9ct yellow gold & diamond set, multistone rings. Plain, narrow, low half round, tapered bands, measures a combined basal width 3.05mm x 0.97mm depth, with open back, underneath.

Feature, "2pce ring set". Comprising, a cluster setting to top, with shoulder stones, claw & bead set (mixed). Plus a contured fitted side ring, with a single row, across the top, bead set.

Polished finish, stamped "375, 375, P*, P*" - acid tested both as 9 carat gold.

Finger size = M.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.

Dimensions = 2.52mm (Diameter) x 1.54mm (D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below).

Thirty Nine bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 0.97mm (average diameter) (smallest)

Dimensions = 1.19mm (average diameter) (largest)

Total Weight = 0.24ct (estimated - see NOTE below).

Total Item Weight = 2.90 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.84 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only.
