## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand finished, raised, 18ct white gold & gemstone set, three stone ring. Plain, narrow, low half round, tapered band, measures, 2.25mm width (at base) x 0.78mm depth, with cut-out underrail, open back settings, underneath.

Feature, "trilogy style" ring design. Comprising, three x six claw settings to top. Housing three oval-shaped, faceted, natural sapphires, claw set. The extended shoulders, of the band tapers up to the top, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = N.

the ring contains;

Three claw set oval-shaped, faceted, natural sapphires, colour is "medium dark pinkish red".  
Average dimensions = 4.69mm (L) x 3.43mm (W) x 2.39mm (D-estimated) (smallest)  
Average dimensions = 4.92mm (L) x 3.99mm (W) x 1.99mm (D-estimated) (largest)  
Total Weight = 0.90ct (estimated - see NOTE below).

Total Item Weight = 4.10 grams, Total Gemstone Weight = 0.90ct, Total Metal Weight = 3.92 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
