Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.72mm in width (at base) x 1.27mm depth, with open back central setting, with 'cross' style support backing, and hollow shoulders.

Feature central bezel setting, housing six Princess cut diamonds, invisible set in two rows. Surrounded by fourteen round brilliant cut diamonds, bead set. All secured between the shoulders of the plain and polished band, each split shoulder having four round brilliant cut diamonds, bead set, with alternating beading design.

Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is W.

The ring contains:

Six invisible set Princess cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).
Dimensions = 1.86mm(L) x 1.85mm(W) x 1.15mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.24ct (estimated - see NOTE below)

Thirty bead set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'H'.
Dimensions (average) = 0.93mm(Dia) x 0.57mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 3.90 grams - Total Gemstone Weight = 0.36ct - Total Metal Weight = 3.83 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
