Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 10ct white gold, diamond set, 'slider' style necklet.

Feature hollow and open back, 'circular' slider style pendant design, housing one hundred and eighty single cut diamonds, pave' set.

The chain being of a filed 'curb' style linkage design, having a small 'bolt' ring type clasp fitted.

Polished finish.

Stamped '10K MHJ' - acid tested as approximately 10 carat gold.

Chain dimensions = 46.00cm (length) x 1.45mm (width).

Pendant dimensions = 21.03mm (diameter) - 3.45mm (width) x 4.30mm (depth).

The necklet contains:

One Hundred And Eighty pave' set single cut diamonds, clarity 'Si & PI' (mixed), colour 'H to I' (mixed).

Dimensions = 0.95mm (average diameter)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.90 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 5.70 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
