## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand-assembled raised, 18ct white gold & diamond set, flexible link necklet/pendant.

Feature, "cluster style" necklet. Comprising, a drop, cluster pendant to bottom, spiral design, cut out to back. Suspended from a fine cable linked chain, with a bolt ring, clasp closures, attached to one end.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Necklet/pendant dimensions = 40.10cm (total length inclusive) x 1.52mm - 8.30mm (width) x 1.52mm - 5.57mm (depth).

The necklet/pendant contains:

One end set round brilliant cut diamond, clarity is "Si", colour is "J", medium cut quality.  
Dimensions = 3.40mm (Diameter) x 2.21mm (D-estimated)  
Total Weight = 0.16ct (estimated - see NOTE below).

Twelve bead set round brilliant cut diamonds, clarity is "Si", colour is "J to K"(mixed), medium cut quality.  
Dimensions = 1.10mm (average diameter) x 0.67mm (D-estimated) (smallest)  
Dimensions = 1.25mm (average diameter) x 0.76mm (D-estimated) (largest)  
Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 4.40 grams, Total Gemstone Weight = 0.24ct, Total Metal Weight = 4.35 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet/pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
