## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold and 9ct white gold, diamond set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.21mm width (at base) x 1.46mm depth, with hollow shoulders, open back settings, and a curved underrail.

Feature central white gold top plate, housing seven round brilliant cut diamonds, bead set. Surrounding is one row of fifteen round brilliant cut diamonds, bead set. The top plate is secured between the extended and pointed shoulders, of the plain and polished yellow gold band. Each of the shoulders, houses five round brilliant cut diamonds, slightly graduating in size and channel set. Rhodium plating to the settings areas.



Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Ring size: N.

The ring contains:

Thirty Two bead set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.15 grams Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.05 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
