Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, flat band of 2.09mm width (at base) x 0.67mm depth, with open back settings.

Feature central raised four claw setting, housing one round brilliant cut diamond, claw set. The central setting is secured between the split shoulders, which are formed into a 'curl' shape. Attached to the 'curls' are one bezel setting, housing one round brilliant cut diamond, bezel set, and one four claw setting, housing one single cut diamond, claw set. The shoulders extend out from the plain and polished band.



Polished finish.

Unstamped - acid tested as 14 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "H".

Dimensions = 3.79mm(L) x 3.66mm(W) x 2.4mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Two claw set single cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 1.45mm (diameter)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 1.90 grams Total Gemstone Weight = 0.24ct Total Metal Weight = 1.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
