Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold and yellow gold plated, gem set, 'cluster' style ring, of hand-assembled construction. Plain, narrow, low half round band of 1.72mm width (at base) x 1.41mm depth, with a curved underrail. Feature central three claw setting, housing one pear shape diamond, claw set. Surrounding is two rows of round brilliant cut diamonds, claw set. The top plate is secured between the upswept shoulders. Each of the shoulders, the gallery and underrail are set with round brilliant cut diamonds. There are a total of eighty- three round brilliant cut diamonds. There is also one round sapphire set on both sides of the gallery, rub over set, in a yellow gold plated setting.



Polished finish. Stamped '14K Sir michael hill 447077183 0.87' - acid tested as 14 carat gold. Ring size: N.

The ring contains:

One claw set pear shaped diamond, clarity is "P1", colour is "H".

Dimensions = 5.47mm(L) x 3.79mm(W) x 2.27mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.29ct (known weight - see NOTE below)

Eighty Three claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 0.80mm(Dia) x 0.49mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Two rub over set round sapphires, colour is "medium pink".

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 3.50 grams Total Gemstone Weight = 0.81ct Total Metal Weight = 3.34 grams (estimated)

NOTE: The diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. 447077183 Dated October 24, 2020. The diamond has also been laser inscribed upon the girdle with IGI (logo) and 447077183 and michael hill. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
