## Valuation for Traditional Retail Insurance Replacement

### Item 1

One 9ct yellow gold and rhodium plated, diamond set, multistone, 'heart' shaped pendant, of hand-assembled construction.

Feature open 'heart' shape, one half of the pendant is set with a total of thirteen round brilliant cut diamonds, graduating in size, and bead set. The pendant is finished with a triangular articulated bail. Rhodium plating to the setting areas.

Pendant dimensions = 22.34mm (ave. length including bail) x 18.06mm (ave. width) x 3.33mm (ave. depth).

Polished finish.

Unstamped - acid tested as 9 carat gold.

The pendant contains:

- Thirteen bead set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "I to K" (mixed).
  - Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)
  - Dimensions = 3.33mm(Dia) x 2.03mm(D-estimated) x 2%(Girdle Thickness) (largest)
  - Total Weight = 0.78ct (estimated - see NOTE below)

Total Item Weight = 1.70 grams  
Total Gemstone Weight = 0.78ct  
Total Metal Weight = 1.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
