Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished raised, 10ct rose gold & rhodium plated underneath, diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.46mm width (at base) x 1.04mm depth, with open back, underneath.

Feature, "cluster style" design to centre, with an entwined ribbon surround. Contains seven round brilliant cut diamonds, to centre grouped, claw set. The extended shoulders, of the band, tapers up, splits into the cross over ribbon design, from both sides.

Polished finish, stamped "10CT MHJ.10" - acid tested approximately 10 carat gold.

Finger size = O.

The ring contains;

Seven claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.74mm (average diameter) x 1.06mm (D-estimated)
Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 2.20 grams, Total Gemstone Weight = 0.10ct, Total Metal Weight = 2.18 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
