Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.86mm width (at base) x 1.33mm depth, with cut-out underrail, open back settings, underneath.

Feature, "single channel row", runs across the top of the band. Housing fifteen baguette cut diamonds, taper in size, channel set. The extended shoulders, of the band, tapers up wide at the top, from both sides.

Polished finish, stamped "750, 18K M" - acid tested as 18 carat gold.

Finger size = P.

The ring contains;

Fifteen channel set baguette diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Average dimensions = 1.93mm (L) x 1.11mm (W) x 0.81mm (D-estimated) (smallest)

Average dimensions = 2.13mm (L) x 1.45mm (W) x 1.06mm (D-estimated) (largest)

Total Weight = 0.35ct (estimated - see NOTE below).

Total Item Weight = 5.70 grams, Total Gemstone Weight = 0.35ct, Total Metal Weight = 5.63 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
