## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 10ct white gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, flat round, tapered band of 3.67mm width (at base) x 1.06mm depth, with open back settings.

Feature central raised four claw setting, housing one round brilliant cut diamond, claw set. Either side of the central setting, there are three four claw settings, each housing one single cut and round brilliant cut diamond. All of the settings are secured to the top of the plain and polished band.

Polished finish.

Unstamped - acid tested and x-rayed as approximately 10 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 4.36mm(L) x 4.33mm(W) x 2.7mm(D-estimated) x 1.5%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Six claw set single cut and round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.15mm (diameter)

Total Weight = 0.04ct (estimated - see NOTE below)



Total Item Weight = 5.40 grams Total Gemstone Weight = 0.36ct Total Metal Weight = 5.33 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
