Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, 2pce ring set, raised 9ct yellow gold & diamond set, multistone rings. Plain, narrow, low half round, tapered band, measures, 3.53mm width (at base) x 1.14mm depth, with curved underrail.

Feature, "2pce ring set". Comprising, an engagement ring, raised rub -over setting to centre, houses one round brilliant cut diamond, rub-over set. The shoulders taper up to the top. Each contains four round brilliant cut diamonds, channel set. The complimenting side band, having a single channel row across the top, containing ten round brilliant cut diamonds, channel set.



Polished finish, stamped "375" - acid tested as 9 carat gold. Finger size = Q.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "P1", colour is "I/J"(inset), medium cut quality.

Dimensions = 3.40mm (Diameter) x 2.07mm (D-estimated)

Total Weight = 0.15ct (estimated - see NOTE below).

Eighteen channel set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 1.96mm (average diameter) x 1.20mm (D-estimated) (smallest)

Dimensions = 2.11mm (average diameter) x 1.29mm (D-estimated) (largest)

Total Weight = 0.54ct (estimated - see NOTE below).

Total Item Weight = 3.20 grams, Total Gemstone Weight = 0.69ct, Total Metal Weight = 3.06 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
