Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast constuction.

Plain, narrow, tapered band of 1.35mm in width (at base) x 1.00mm depth, with open back (drilled) settings.

Feature single row spanning across the top of the plain and polished band, housing nine round brilliant cut diamonds, tapering in size, claw set in shared claw settings. All secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '9K CLAIRE ARISTIDES' - acid tested as 9 carat gold.

Finger size is L.

The ring contains:

Nine claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed).

Dimensions = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 1.30 grams Total Gemstone Weight = 0.40ct Total Metal Weight = 1.22 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
