## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, half round, tapered band of 2.15mm width (at base) x 1.18mm depth, with hollow shoulders, open back settings, and a curved underrail.

Feature central round illusion top plate, housing seven round brilliant cut diamonds, largest to the centre, illusion set. The top plate is secured in a four claw setting, and in between the extended and pointed shoulders of the plain and polished band.



Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Si", colour is "J",

Dimensions = 3.00mm(Dia) x 1.83mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.11ct (estimated - see NOTE below)

Six illusion set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 2.50 grams

Total Gemstone Weight = 0.27ct

Total Metal Weight = 2.45 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
