## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, multistone ring, of hand-assembled

Plain, narrow, low half round, tapered band of 2.01mm width (at base) x 0.76mm depth, with open back settings.

Feature central assymetrical arrangement of ten white gold shared claw settings, each housing one round brilliant cut diamond, claw set. The settings are supported with an open wire base. The settings are secured between the extended and pointed shoulders in a 'wrap around' style, of the plain and polished yellow gold band.



Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: Q 1/2.

The ring contains:

Ten claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.90 grams Total Gemstone Weight = 0.27ct

Total Metal Weight = 2.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
