Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, dress style ring, of cast construction.

Plain, narrow band of 2.16mm in width (at base) x 1.22mm depth, with curved underrail.

Feature central four claw setting, housing one Princess cut diamond, claw set. To the base each side is one round brilliant cut diamond, rub-over set. All secured between the extended shoulders of the plain and polished band. One round brilliant cut diamond is gypsy set into the 'O' of FOREVER to the inner curve.

Polished finish - stamped '750 LBLD DIA FOREVER 21' - acid tested as 18 carat gold. Finger size is O.

The ring contains:

One claw set Princess cut diamond, clarity 'Vs2', colour 'G'.

Dimensions = 3.22mm(L) x 3.18mm(W) x 2.45mm(D-estimated) x 2.5%(Girdle Thickness)

Total Weight = 0.21ct (known weight - see NOTE below)

Three rub-over set & gypsy set (mixed) round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'F/G'.

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.015ct (estimated - see NOTE below)

Total Item Weight = 3.01 grams - Total Gemstone Weight = 0.225ct - Total Metal Weight = 2.965 grams (estimated)

NOTE: The centre diamond has been laser inscribed upon its girdle with IGI F3J59230. No diamond certificate was provided at the time of this valuation or available online. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weights of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
